

A global game plan for COP 28

While COP 28 represents a pivotal moment for climate adaptation, it is nearly a decade in the making. In 2015, the UNbrokered Paris Agreement established a Global Goal on Adaptation to enhance countries' capacity to strengthen resilience and reduce vulnerability to climate change.

For the past two years, negotiators and experts have been discussing the technical details of the Goal(...) So what exactly needs to happen at COP 28 to put climate adaptation on par with mitigation efforts?

- Governments must reach an ambitious agreement on the framework of the Global Goal on Adaptation, one that sends a clear message on the need to accelerate action so all countries, communities, ecosystems, and economies can have in place structures and systems to withstand the ravages of climate change.
- The framework needs to contain robust and science-based quantitative and qualitative targets to guide global action and enable the tracking of progress.
- Countries need to mobilize financial resources to achieve the framework's proposed targets. Otherwise, it risks being a hollow agreement. Importantly, this means ensuring that at least 50% of overall climate finance flows to low-income countries in the greatest need of adaptation support.

CIVIL SOCIETY ORGANIZATIONS: WHAT WE NEED FROM COP28 IS FOR COUNTRIES TO FINALLY AGREE ON LIBERATING US FROM FOSSIL FUELS

Given the COP28, civil society organizations have issued statements and petitions urging authorities for the transition from fossil fuels to clean energy since early in the month. The World Federation of Public Health Associations, International Council of Nurses, and the World Medical <u>Association</u> have initiated actions and appeals for countries to expedite the phasing out of fossil fuels and transition to clean energy sources. Also noteworthy is a statement from over 200 health-focused journals urging the World Health Organization to declare climate change and biodiversity loss a global health emergency. ActionAid has established five benchmark parameters for climate justice, anticipating some relevant points for the success of discussions within the framework of COP28. The International Federation of Medical Students Associations published a message stating the urgent need for an accelerated, fair, and equitable elimination of fossil fuels as the decisive path for health for all. Greenpeace urged countries to take a stance in favor of halting new projects in oil, carbon, or gas. OXFAM informed that their priority in COP28 is questioning the deeply unjust reality of wealthy countries driving the climate crisis, while the poorest, marginalized groups and low-income countries bear the cost... continue reading here
